SELLER'S ANIMAL NON-REFUNDABLE DEPOSIT CONTRACT

THIS AGREEMENT, made and entered into this _____ day of _____, 20____, between the following prospective buyer(s) (hereinafter "BUYER"), and Rosann M. Bentley, 5465 Clarksville Pike, Whites Creek, TN, 37189 (hereinafter "seller"), relates to the following listed below.

This agreement is that the BUYER understands and agrees they are paying a \$250.00 non-refundable deposit. The Buyer understands that, if the BUYER decides to decline a puppy for any reason during the pregnancy the deposit can be moved to another litter of their choice that is available. If the BUYER declines a puppy after the birth the deposit is not available to move, or if the BUYER never accepts or comes to pick up their puppy the deposit is forfeited. The BUYER understands the female (1.F) listed below may not be bred to the same male (1.E) listed below for her next breeding. The BUYER understands it is the SELLER'S choice of Sire to breed to the Dam. The BUYER understands if the deposit is moved to another litter, it is possible that the same spot chosen from the previous litter may not be the same spot in the new upcoming litter. This is because deposits were already received to hold spots for the new upcoming litter. Make sure there is another female you like to be moved to because once you send a deposit there is no money refund in whole or part. If you do not like any other dogs or another upcoming breeding pair then don't not send us a deposit. After the deposit the Remainder of puppy purchase paid if full with cash only when BUYER picks up the puppy in person. We DO NOT dock tails, NO exceptions. Your puppy WILL have a tail!
